ALAMEDA COUNTY

Cooking On-Site

Quarterly Cost: \$333 (Veterans exempt)

- Complete Temporary Food Facility Permit Application and submit to Alameda County Health Department

Pre-Packaged Goods or Food Truck/Cart

Quarterly Cost: \$186 (Veterans exempt)

- Complete Mobile Food Facility Permit Application and submit to Alameda County Health Department

CONTRA COSTA COUNTY

Cooking On-Site or Open-Air Contact Products

Quarterly Cost: \$150

- Complete Contra Costa Temporary Food Facility Permit Application and Submit to PCFMA
- Proof of certified commercial kitchen with CA Processed Food Registration or county health permit submitted to PCFMA
- Enclose booth on all sides during market hours of operation

Pre-Packaged Goods

Annual Cost: \$125

- Sampling needs to be in closed container such as squirt or shaker bottles

SAN FRANCISCO COUNTY

Cooking On-Site or Open-Air Contact Products

Quarterly Cost: \$300 - \$1,200

- Vendor must complete TFF Concessionaire Application or Mobile Food Facility Application
- PCFMA must submit approval letter on behalf of TFF vendor

Pre-Packaged Goods

Annual Cost: \$400 - \$800

- Letter from PCFMA granting approval into specific market
- Need CA Processed Food Registration (PFR) and/or County Food Facility Permit
- Register with San Francisco Treasury (\$40-\$60)
- Submit RFV Application to SF Department of Public Health (\$540)
- City and County SF Business Registration Certificate/Receipt
- Include written sampling procedures (if applicable)
- Submit packaged food labels



SAN MATEO COUNTY

Cooking On-Site or Open-Air Contact Products

Annual Cost: \$200-\$500

- Complete [RC2 Application](#) for each market you're going to attend in San Mateo County
- Submit RC2 Application(s) and fees to Market Manager
- Market Manager will submit application and fees to San Mateo Health Department at least 14 days prior to vendor attending market

Pre-Packaged Goods

Annual Cost: \$200-\$400

- Complete [RC1 Application](#) for each market you're going to attend in San Mateo County
- Submit RC1 Application(s) and fees to Market Manager at least
- Market Manager will submit application and fees to San Mateo Health Department at least 14 days prior to vendor attending market

SANTA CLARA COUNTY

Pre-Packaged and Cooking On-Site Products

Annual Cost: \$175 - \$400

- Submit [Temporary Food Facility \(TFF\) Application](#) and [Commissary Agreement Form](#) for each market to PCFMA
- Market Manager submits TFF Application and Fees to Santa Clara Department of Environmental Health 14 days prior to vendor start date. Santa Clara invoices vendors directly after issues pre-approval

SOLANO COUNTY

Pre-Packaged and Cooking On-Site Products

Annual Cost: \$280 - \$507

- Submit [Solano County Special Event Food Vendor Application](#) to Solano Department of Resource Management 30 days before starting at market
